Termination can also take place

a) where the legal structure or ownership of one of the parties has changed in such a way as seriously to affect the result that the other party could reasonably expect from the Agreement

b) if the other party becomes insolvent, makes any assignment for the benefit of its creditors or is placed in receivership, liquidation or bankruptcy.

- 12.3 No claims for indemnity or compensation can be lodged by reason of the termination of the Agreement, except where these claims are based on breach of Agreement by one of the parties.
- 12.4 When the Agreement is terminated, the Service Center shall return all available material and documents received.

### 13. Disputes

- 13.1 This Agreement shall be governed by and interpreted according to Swedish law.
- 13.2 The Parties shall endeavor to negotiate and amicably settle disputes arising between them in connection with this Agreement. If the Parties do not succeed in arriving at an amicable settlement, either Party can take such dispute to arbitration.
- 13.3 Final settlement of disputes in conjunction with this Agreement shall be in accordance with the regulations for the Arbitration Institute of the Stockholm's Chamber of Commerce in Sweden in expedited arbitration proceedings. The arbitration proceedings shall take place in Stockholm, Sweden.


### 14. Notices


